## Speaking Opportunities First Announcement and Call for Papers

**THEME: *“Towards a SMART Broadband Caribbean Community”***

The 29th Annual Telecommunications Conference and Trade Exhibition CANTO 2013, will be held at the Renaissance Aruba Resort & Casino, from the 14<sup>th</sup> – 17<sup>th</sup> July, 2013. Through its highly interactive technical program, the conference will provide an opportunity for the academic and industrial community to address new research challenges, share solutions and discuss issues in information and communication technology (ICT) pertaining to modern telecommunications and increased business competitiveness.

CANTO 2013 will also include a Trade Exhibition where over 100 technology suppliers, systems, products and ICT services vendors will showcase their products and services leading to increased competitiveness in businesses and operations for operators, governments and regulators.

## **GENERAL INFORMATION**

### **Accepted proposals may be slated by CANTO reviewers in one of the following categories:**

- **Managed Session:** An organized session with a suggested list of speakers, where the proposer oversees the speakers and logistics from beginning to end.
- **Panel:** A forum of experts designed to disseminate, compare and debate information.
- **Session Presentation:** the formal presentation of papers to a designated audience with a question and answer period.

### **Paper proposals MUST include the following:**

- Title of proposed paper
- An abstract of about 75 words, exactly as it will be published on the website. Full papers, graphs, charts, diagrams, slides etc will not be reviewed. The abstract should provide sufficient information to allow assessment of the scope and content of the paper and must be in text form.
- Session Name and Topic
- A short biography of no more than 75 words, reviewing the principal author's and co-author(s) professional and educational background exactly as it will appear in publications and on CANTO's website. Complete contact information ( full address, telephone and fax numbers, email address) must be included with each biography
- An electronic head shot of the presenter
- Name and complete contact information of presenter, if different from the principal author
- Five (5) key words for indexing purposes.

## **Important Rules and Requirements**

- Proposals must be prepared in English.
- Commercialism or citation and promotion of trade names must be avoided and will be viewed as vendor presentations. CANTO reserves the right to decline any papers with commercial content without notice.
- The paper should be original and not have had prior coverage or circulation, such as presentation at other conferences or prior publication.
- Proposals should have any necessary organizational clearance before submission
- Authors whose proposals are accepted will be invited to submit a first draft of their full papers for further consideration. The invitation to submit a first draft does not mean automatic inclusion of paper in the conference programme. All first drafts must be submitted by **Friday 19<sup>th</sup> April 2013**.
- No author can present more than once during the conference
- **All proposals must be sent via e-mail and must have as the subject Speaking Opportunity CANTO 2013. Failure to comply with this requirement may result in your proposal not being reviewed for acceptance in the Agenda**
- Upon acceptance based on the first draft, preparation guidelines for the complete manuscript will be sent to authors. The manuscripts must meet the requirements and received in the format specified in the guidelines by **Friday 5<sup>th</sup> July 2013**. Where necessary, CANTO reserves the right to replace speakers.
